ROBERT B. HUTCHINGS OFFICER OF THE YEAR AWARD

The Officer of the Year Award is presented annually to a member of the Utah Narcotic Officers Association in recognition for his/her exemplary performance in a hazardous or life threatening situation.

Award nominees have gone above and beyond in the line of duty, by demonstrating extraordinary bravery, dedication and innovation to the eradication of the illegal use, possession, manufacturing or sale of controlled substances in the State of Utah.

To be a recipient of this award, the officer must be a dues paying member or honorary member whose nomination has been typewritten on the Officer of the Year Award application and submitted to the UNOA Awards Selection Committee. The awards committee will then review each nomination and make their selection.

All nominations for Officer of the Year will be considered for the Robert B. Hutchings Award. All selections will be forwarded to the elected Board of Governors for final approval. Awards will then be presented at the annual Utah Narcotic Officers Association conference.
