*Available on first come basis and limited to two slots per region

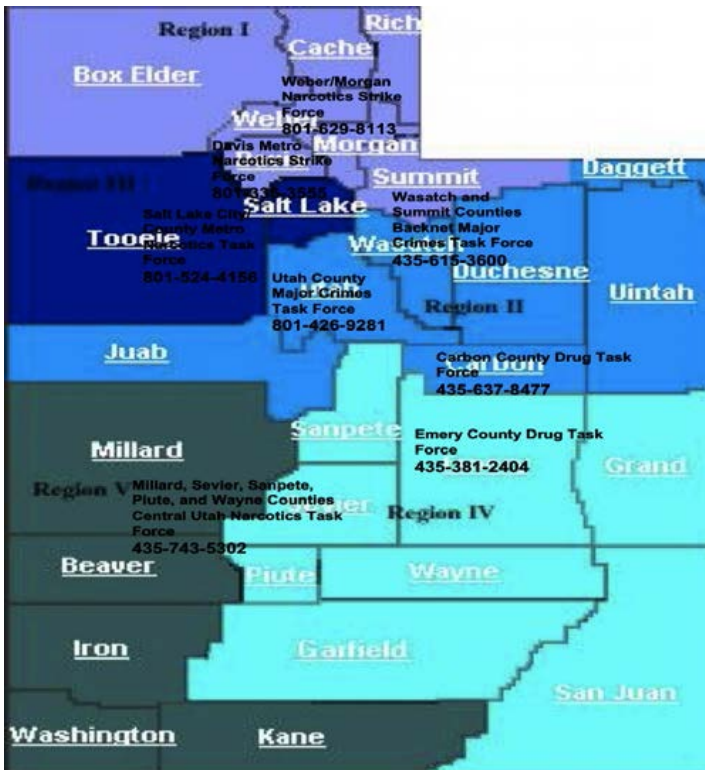
If both regions' slots are not requested then those slots can be allocated to another region by date submitted.
